Governor Lynch's July 14, 2005 Executive Order

Sets a goal of reducing energy use by 10% in state facilities, in conjunction with the U.S. EPA's *Energy Star Challenge – Building a Better World 10% at a Time.*

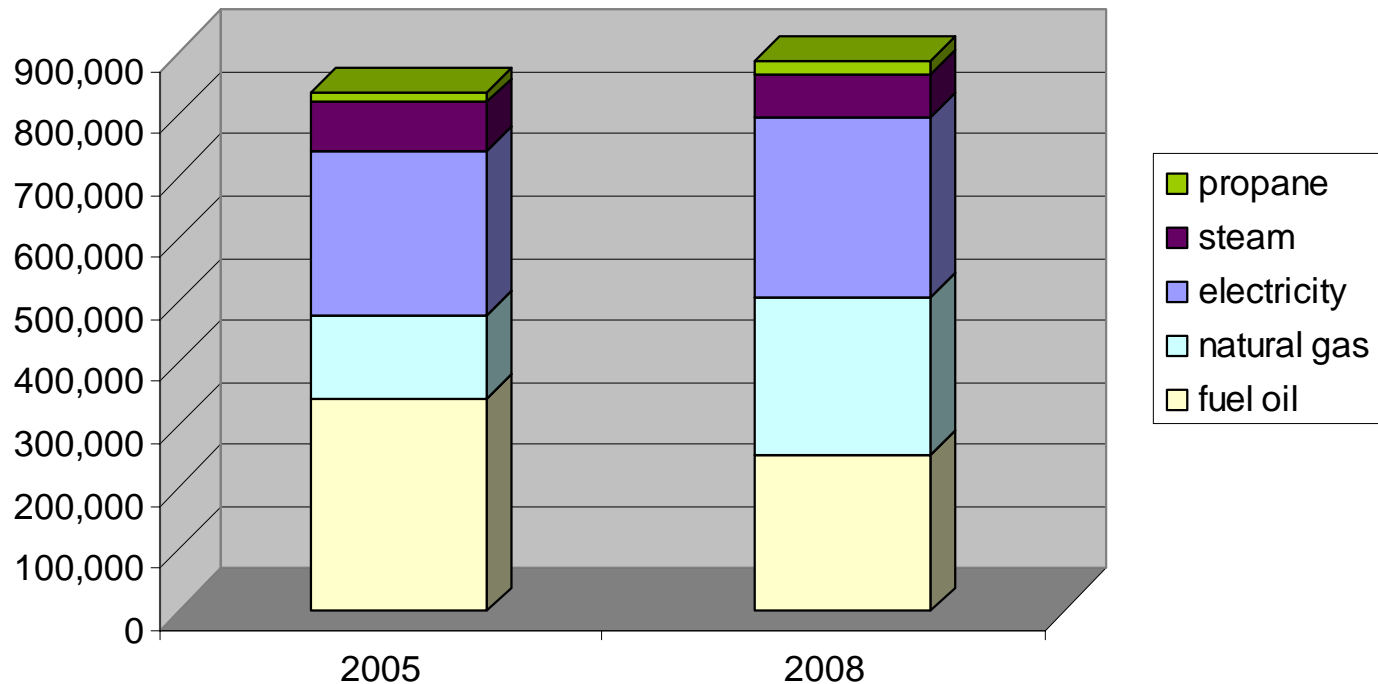

Energy Efficiency in State Government Annual Meeting

- ❑ One of the most dramatic changes in energy use was the substitution of natural gas for heating oil in many of the state's boilers.
- ❑ Natural gas is cheaper, cleaner, and emits fewer greenhouse gases than oil.
- ❑ This transition actually *reduced* the amount of greenhouse gas emissions resulting from heating our buildings, despite an increase in energy use.

Eleven of 17 property-owning agencies showed an overall decline in energy use per square foot of heated space between baseline year of FY2005 and FY2008.





Energy Efficiency in State Government Annual Meeting

\$1,228,396 = Amount State would have saved in FY2008 if it had used the same amount of energy in State-owned buildings as it did in FY2005.

\$3,156,919 = Amount State would have saved in FY2008 if it had used 10% less energy in State-owned buildings than it did in FY2005.

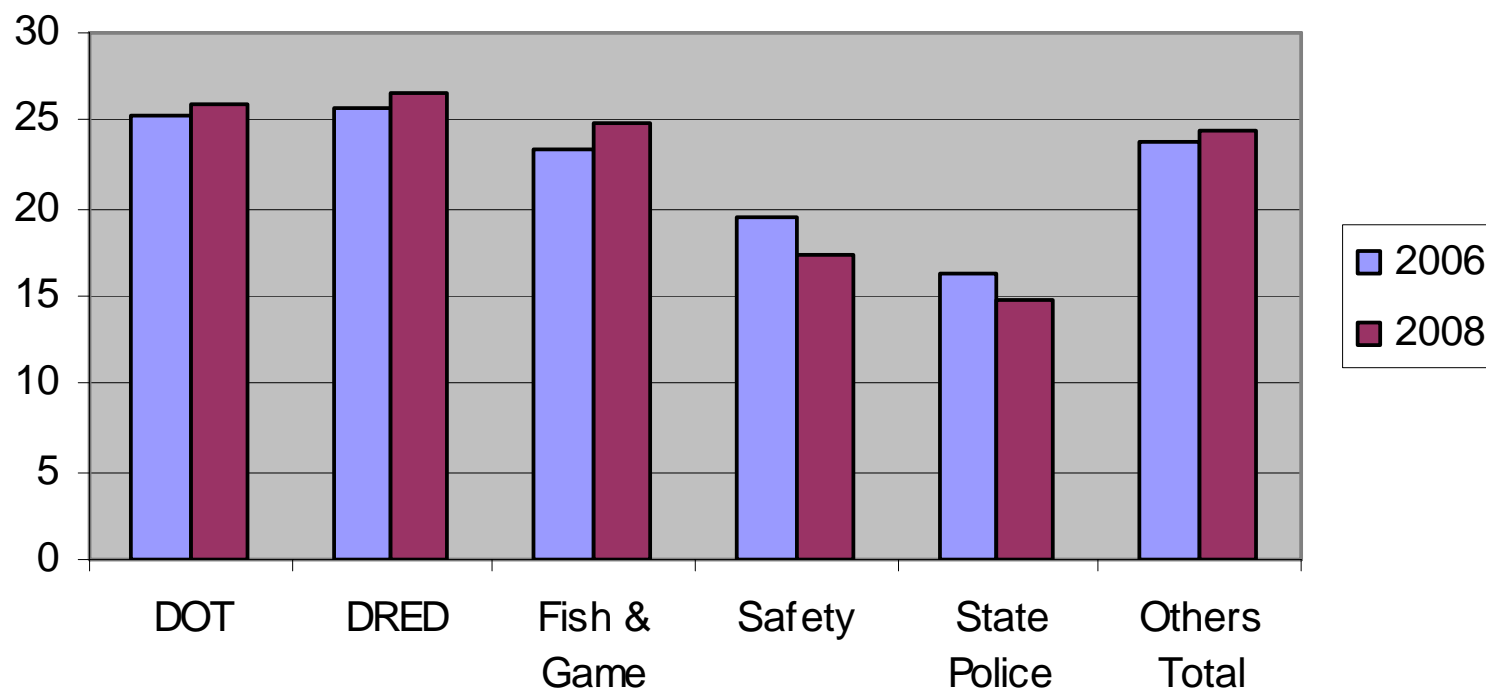

NH State Fleet - Highlights

- ☐ New vehicle purchasing requirements for 2009 (or get a waiver):
 - 32 mpg for passenger vehicles
 - 24 mpg for light duty trucks
- ☐ Department of Transportation established “Fuel Reduction Initiative” for efficient fleet operation.

NH State Fleet – Highlights

- ❑ Department of Safety established idling time policy for traffic details (15 minutes out of every hour).
- ❑ Department of Labor implemented a 55 miles per hour speed limit policy to save fuel.

NH State Fleet – Priorities and Opportunities

- ❑ Dept. of Administrative Services to issue state-wide RFP for preventative maintenance of state-owned vehicles.
- ❑ SB 68 – Lowers minimum annual mileage requirements and provides for fleet averaging.
- ❑ Dept. of Transportation pilot project for statewide fleet management.





Energy Efficiency in State Government Annual Meeting

Clean Fleets Policy – Some Green Driving Tips

- 1. Avoid Idling** – It translates to 0 miles per gallon so turn off the engine if parked for longer than 30 seconds.
- 2. Drive Sensibly** – Rapid starts and stops can lower gas mileage by 5-33%.





Energy Efficiency in State Government Annual Meeting

Clean Fleets Policy – Some Green Driving Tips

- 3. Maintain Optimum Highway Speed –**
Speed over 60 mph uses more fuel.
Observing the speed limit can improve mileage by 7-23%.
- 4. Use Air Conditioning at Higher Speeds –**
Over 40 mph, the drag from open windows uses more gas than using the AC.

Clean Fleets Policy – Some Green Driving Tips

5. Use Cruise Control - Save up to 7% more fuel, but make sure you use this tips on flat lands. You'll burn more gas than average if you use cruise control on hills.

- ☐ Pilot Program for 6 agencies and 115 state employees, summer 2008.
- ☐ Full implementation in Governor's Office (35 employees) and DES (500+ employees) for initial agency wide launch, fall 2008.
- ☐ Now being rolled out to all agencies.

Kilowatt Countdown

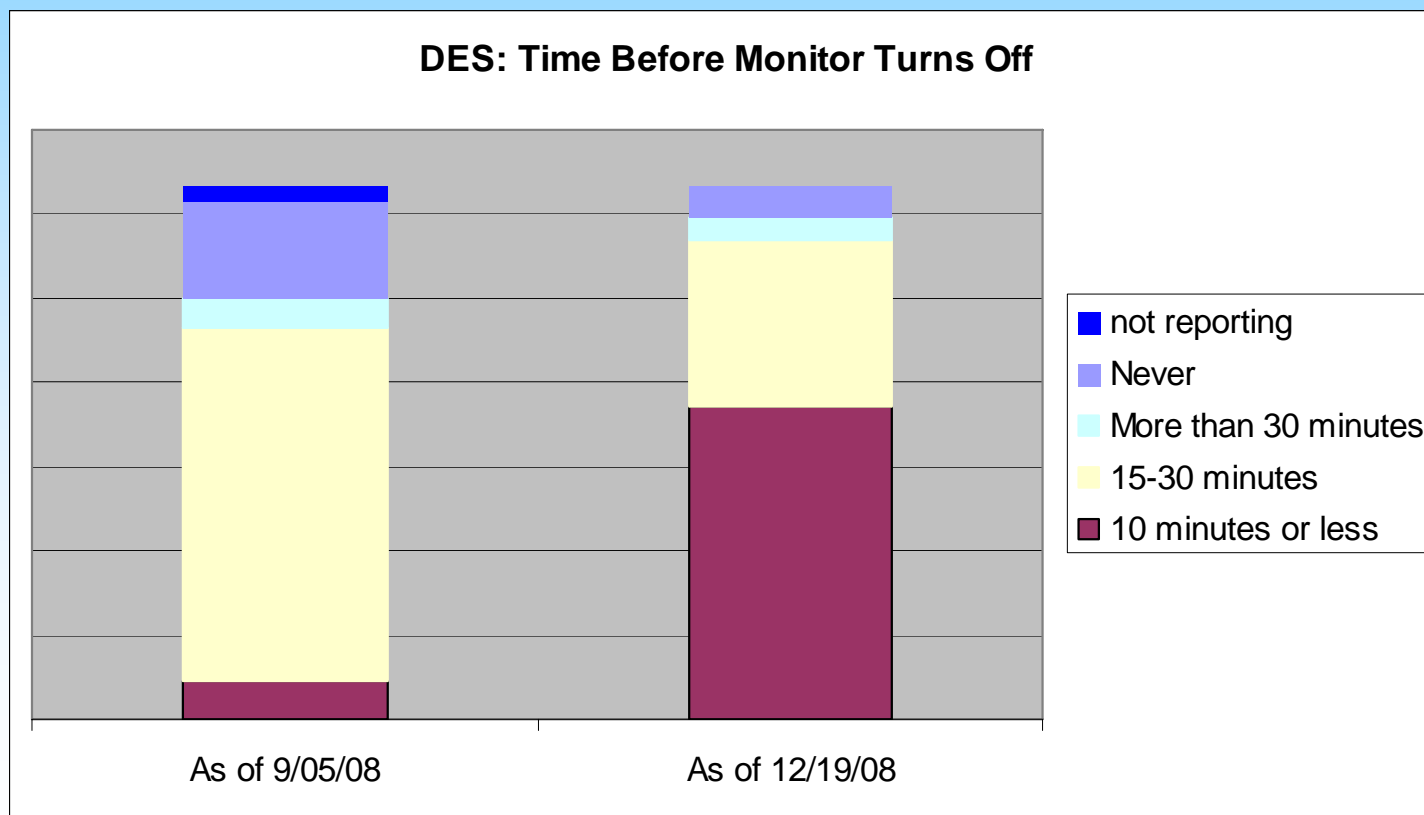
- ☐ Power Saving Settings
 - Set monitors to power down or turn off after 10 minutes.
 - Set computers (and laptops) to enter system standby after one hour.
- ☐ Security Settings
 - Set password protection on after 20 minutes.

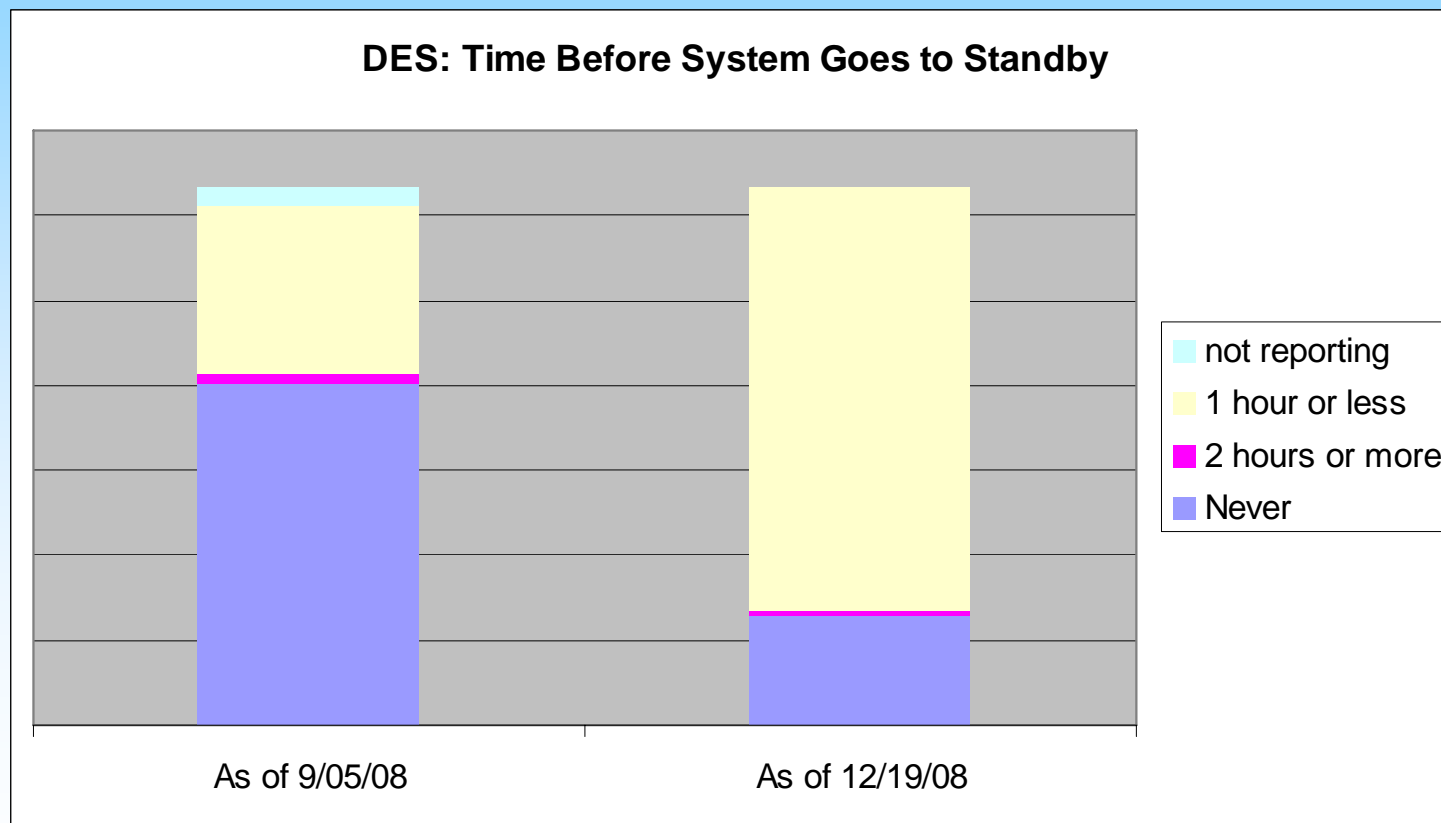

Funding for Energy Projects

- ☐ “Demand Response Program” is offered by ISO New England, the manager of the region’s electricity grid.
- ☐ All large State-owned facilities with capacity to reduce or eliminate electricity demand during peak events (typically on hot summer days) should consider participating.

Funding for Energy Projects

- ☐ Facilities with emergency generators should also consider participating.
- ☐ ISO New England will pay the State to reduce demand or increase generation during peak events.
- ☐ Funds will be used for energy efficiency projects in State facilities.
