Other 2010 ideas discussed at legislative "Energy Caucus" meeting on 9/18/09:

Least cost approach to Energy Efficiency

- Develop a statutory mechanism that provides incentives to utilities to invest in energy efficiency to reduce consumption prior that is cheaper than purchasing supply.
- In Massachusetts all utilities are working together on a statewide proposal to increase energy efficiency under the Green Communities Act; several NH electric utilities do business in MA, and will have experiences upon which to draw.

Language from the 2008 Massachusetts Green Communities Act:

Electric and natural gas resource needs shall first be met through all available energy efficiency and demand reduction resources that are cost effective or less expensive than supply. The cost of supply shall be determined by the public utilities commission with consideration of the average cost of generation to all customer classes over the previous 24 months.

Energy Codes/Energy Consumption in State Buildings

- Look at planned adoption of updated 2009 Energy Code to determine if additional legislation is warranted to improve energy retrofits of state buildings.
- As a follow up to SB 73 of 2009 (requiring state departments to reduce energy consumption and to make an annual report on their energy consumption reduction efforts), which was retained for further study, develop a plan to further reduce fuel costs for state government.

<u>Incentives for energy conservation through voltage regulation:</u>

• Look at language from other states that provide incentives for utilities to invest in voltage regulation that results in energy savings.

Enable towns to add tax exemption for EE investments

- 75 NH towns already have some form of RE tax exemption under current law.
- Enabling legislation would give towns option to add exemption for qualifying EE building investments.
