1. **Welcome and Introductions.** Meeting started at 9:05 am
2. **PUC Commissioner Honigberg** announced that appointment terms for several Board members expired at the end of 2014 so those individuals need to provide new letters of appointment to continue as EESE Board members. PUC will assist with details. A sufficient number of Board members remain formally active – quorum confirmed.
3. **EESE Board Leadership.** Kate Peters expresses interest and willingness to continue as Acting Chair. So moved and approved by Board.
4. **Minutes of November 21, 2014 EESE Board Meeting**

Minutes adopted with several changes to attendee names and affiliations.

6. **Presentation – NH Residential Rooftop Solar PV – Permitting, Zoning, and Interconnection Guide.** Presented by

Provided a presentation which included an overview of the new Residential Rooftop Solar Permitting and Zoning guide developed through a regional US DOE Rooftop Solar Challenge II grant in collaboration with Clean Energy States Alliance (CESA). The Guide provides a summary of useful information related to Residential Rooftop Solar PV including: State Policies; Permits & Fees; Zoning & Laws; Soft Costs; Barriers. 7. **Discussion about letter from EESE Board to Joint Legislative Fiscal Committee and others supporting Renewable Energy Fund.** Discussion about the Board authorizing and sending a letter similar to that dated July 25, 2014 from Board expressing concern that Alternative Compliance Payments not be diverted from the REF and they be used as intended to operate programs and stimulate investment in renewable energy technologies. The 2014 letter also referred to the Resolution of the EESE Board of June 14, 2013 expressing similar sentiments. Motion was made, seconded and approved to send letter to Governor, Joint Leg. Fiscal Committee, House & Senate Finance Committees, House & Senate Ways and Means Committees, House Speaker, House Majority Leader, Senate Pres. and Senate Majority Leader similar to the July 25, 2014 letter expressing support for the Renewable Energy Fund. All voting members voted in favor of sending a letter; with the exception of those abstaining: OEP and PUC. (Note: Susan Chamberlin of NH OCA was not present to participate in this vote).

## 8. Board and Program Updates

### i. Legislative

There was review and discussion of LSRs, many of which have designated HB or SB status now, relative to energy issues. The list will be made available on the EESE Board website for this meeting.

### ii. PUC

Steve Eckberg provided year end Residential PV rebate numbers. In calendar 2014, 541 applications were received, 398 rebates paid totaling \$1,390,405 corresponding to total cost of projects of \$13,386,083. For comparison, in 2013, there were 268 applications received, 267 rebated paid totaling \$910,049 corresponding to total cost of projects of \$5,331,094.

Karen Cramton provided updates on other PUC and OEP programs. We understand that PUC Electric Division will be presenting next month on the Energy Efficiency Resource Standard (EERS) proposal that has been developed.
