64:1 Water Resources Management and Water Conservation; Regional Cooperation; Report by Public Utilities Commission and Department of Environmental Services.

I. The public utilities commission and the department of environmental services shall prepare a report which evaluates whether existing regulatory structures encourage or discourage regional cooperation for water resources management and water conservation. The report shall include:

(a) An analysis of the effect of public utilities statutes and rules on regional cooperation for water resources management;

(b) An analysis of how the authorizing statutes and the rules and policies of the public utilities commission and the department of environmental services affect water conservation in New Hampshire; and

(c) Findings and recommendations for future action to encourage water conservation and regional cooperation on water resources management matters.

II. The public utilities commission and the department of environmental services shall report their findings and any recommendations for proposed legislation to the senate president, the speaker of the house of representatives, the chairpersons of the senate environment, the senate energy and economic development, the house resources, recreation, and development, and the house science, technology, and energy committees, the governor, and the state library by June 30, 2001.
