On March 15, 2012 Northern New England Telephone Operations LLC d/b/a FairPoint Communications-NNE (FairPoint) filed an Emergency Motion for Enforcement of Commission Order. By that motion, FairPoint requests that the Commission issue an "order compelling payment of past due CCL charges " by March 31, 2012 or "the establishment of such other arrangements by individual opposing parties as are acceptable to FairPoint."
