Granite State Electric Company d/b/a National Grid Annual Storm Fund Report

1. Introduction

Granite State Electric Company d/b/a National Grid ("National Grid" or "Company") is submitting the following Annual Storm Fund Recovery Report for 2009, in compliance with the requirements set forth in Exhibit GSE-7 of the Company's Rate Plan Settlement (the "Settlement") in Docket No. DG 06-107 approved by Commission Order No. 24,777.

In 2009 there were no qualifying "major storms" (as defined in Exhibit GSE-7) in the state of New Hampshire. As such this report does not contain a description of any storms in 2009 or a summary of damages to the distribution system.

However, due to the substantial damages in the December 12, 2008 ice storm that affected approximately 24,164 customers over 528 square miles and caused interruptions in 17 of the 21 communities served by the Company, the Company is providing collections credited to the storm fund and the details of qualifying storm costs that were charged to the fund during the preceding calendar year as required by Section 5 of Exhibit GSE-7.

Despite the damage and large number of customer interruptions in that storm, National Grid led a successful storm restoration effort, and succeeded in restoring all of its New Hampshire customers by December 19, 2008.

2. <u>Collections Credited to the Storm Fund</u>

Exhibit 1 is a report of the annual Storm Fund Activity. This report shows the opening balance in the fund, monthly contributions, monthly interest applied and charges to the Storm Fund, both for the year ended 2008 and the year ended 2009.

In Exhibit 1, page 1 of 2, storm cost for both the December and June storm of 2008 have increased from the prior years report from \$399,109 to \$548,553 due to final accounting adjustments made after the 2008 report was prepared. There has also been an adjustment to interest expense from the prior year's report as storm cost were not accounted for in the monthly calculation of accrued interest.

3. Details of Qualifying Costs Charged to the Storm Fund in 2008

Exhibit 2 shows the charges to the Storm Fund related to the December 11-12, 2008 ice storm. Exhibit 3 shows the updated charges to the Storm Fund related to the June 29, 2008 storm.
