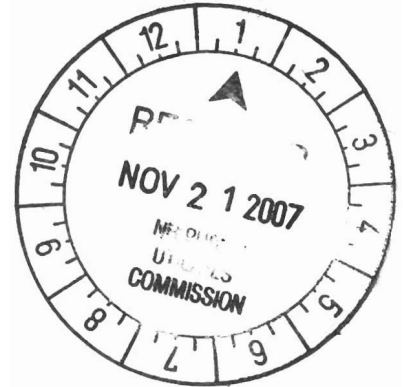

Dear Secretary Howland:

Enclosed please find seven copies of the revised exhibits of Robert A. Baumann, on behalf of Public Service Company of New Hampshire (PSNH), supporting a revised request for an average Stranded Cost Recovery Charge (SCRC) of 0.72 cents per kilowatt-hour for effect on January 1, 2008 through December 31, 2008. On September 7, 2007, PSNH filed for a SCRC rate of 0.88 cents per kilowatt-hour.

The revised rate requested today is based upon an agreement among to parties to include in the SCRC calculation the so-called "net obligations" which were originally included in the Default Energy Service rate filing. The Technical Statement of Stephen R. Hall and Robert A. Baumann further explains what additional items will be reflected in the SCRC calculation. PSNH is currently billing an average SCRC of 1.43 cents per kilowatt-hour.
