Dear Secretary Howland:

Enclosed please find seven copies of further revised attachments to the pre-filed Direct Testimony of Robert A. Baumann. This filing is made in a response to a Record Request propounded at the hearing on June 11, 2008. Exhibit No. 6 was reserved for this information.

Based upon higher forecasted market prices and more recent actual data through the month of May, Public Service Company of New Hampshire ("PSNH") is requesting a decrease in the average Stranded Cost Recovery Charge ("SCRC") from the current charge of 0.72 cents per kilowatt-hour to 0.65 cents per kilowatt-hour. The decrease from the previously requested charge of 0.69 cents per kilowatt-hour is attributable to an increase in forecasted market prices, which has caused a corresponding decrease in the above-market cost of purchases from IPPs.

We are not including updated rates and charges with this filing. As explained by Mr. Hall at the hearing, the calculation of final SCRC rates and charges is dependent upon the level of transmission and energy service rates approved by the Commission. Therefore, PSNH will await receipt of the Commission's orders in dockets DE 08-069 and DE 07-096 and will then calculate SCRC rates and charges for inclusion in PSNH's tariff.

As suggested by Attorney Hatfield at the hearing, PSNH will schedule a conference call to discuss this filing with the Staff and the Office of Consumer Advocate and answer any questions they may have. PSNH will file rates and charges for individual rate classes early next week.
