Dear Mr. Nestor:

On January 18, 2008, Verizon New Hampshire (Verizon) submitted a tariff filing revising Auxiliary Exchange Services in Verizon's NHPUC No. 83 Exchange and Network Services tariff. The tariff goes into effect, by operation of law, if not acted on by February 17, 2008. The filing revises rates associated with the 12 and 24-month commitment plans for FIOS Bundle Discount Plan as well as renewal rates.

Staff reviewed the documentation filed in support of the tariff filing and requested the effective date of the tariff be extended by 30 days from the proposed effective date of February 17, 2008 to March 18, 2008. According to Staff, additional time is needed to review this filing.

Pursuant to RSA 378:6 IV, "[t]he commission may, in its discretion and with reasonable explanation ... extend the time for determination by 30 days." In order to evaluate the information requested by Staff, but not yet received, the Commission believes it is reasonable to extend the effective date of the tariff by 30 days to March 18, 2008.
