Enclosed for filing with the Commission is a copy of a power purchase agreement between PSNH and the New Hampshire Electric Cooperative (NHEC) providing for the sale to NHEC of a portion of the energy, capacity and Renewable Energy Certificates purchased by PSNH from Lempster Wind.

In its testimony filed on May 29, 2008, PSNH indicated that this agreement would be filed with the Commission once it was executed. PSNH is not seeking Commission approval of this agreement, since the agreement is subject to the jurisdiction of the Federal Energy Regulatory Commission.

The enclosed agreement does not include any of the attachments (the Lempster PPA, the Lempster REC Option Agreement, and the Lempster Interconnection Agreement). These attachments have already been filed with PSNH's confidential filing of testimony on May 29, 2008, and have been granted protective treatment by the Commission.
