Dear Ms. Fox:

Public Service Company of New Hampshire, respondent in the above captioned appeal by petition, wishes to bring a matter to the attention of the court. The appellant in the above-captioned proceeding, Freedom Partners, LLC, was dissolved as a New Hampshire limited liability company effective August 31, 2009. A copy of the certificate of cancellation is attached. That cancellation filing indicates that the limited liability company was being dissolved because the company was moving to Texas. Upon information and belief as of September 11, 2009, based upon information obtained from the Texas Secretary of State's office, Freedom Partners, LLC has not reorganized in the State of Texas. Furthermore, Freedom Partners, LLC has not registered with the New Hampshire Secretary of State's office as a foreign limited liability company as required by RSA 304-C:62, *et seq.*


Under RSA 304-C:56 II (a), persons winding up the affairs of a limited liability company may "Prosecute and defend suits." The instant proceeding is an appeal from an administrative agency, the public utilities commission, in which the appellant was a voluntary intervenor granted limited rights of intervention. As such, the instant appeal is not one related to "winding up the business or affairs of the limited liability company", which has been dissolved and is no longer qualified to do business in this state, and will not result in any outcome related to the winding up of the affairs of Freedom Partners, LLC.
