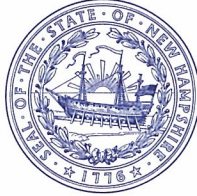

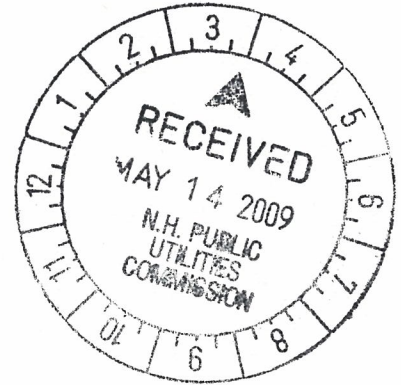

On May 6, 2009, Hampstead Area Water Company (HAWC) filed with the Commission a letter requesting a supplemental order in the above captioned docket. HAWC seeks express approval from the Commission to provide a security interest in its real and personal property as a condition of its proposed borrowing from the State Revolving Loan Fund for the purposes as detailed in Order No. 24,927. Since the Stipulation Agreement filed by HAWC, Staff and OCA presented at hearing did not specifically address this requirement and seek approval from the Commission for it, Order No. 24,927 does not provide it.

Staff supports the request. I have also been authorized by the OCA to represent that OCA does not oppose the request.
