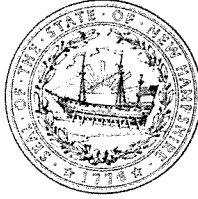

Dear Mr. Toomey:

On August 29, 2008, Iberdrola Renewables, Inc. (Iberdrola) submitted an application requesting certification for the Lempster Wind LLC Project (Lempster) as eligible to produce Class I renewable energy certificates (RECs) pursuant to RSA 362-F, New Hampshire's Renewable Portfolio Standard law. Staff has reviewed the application and recommends approval noting that the Lempster application was complete on August 29, 2008.

Class I eligibility requires a facility to have begun the production of electricity after January 1, 2006 and to use certain sources as the primary fuel to produce that electricity, one of which is wind energy.

The application indicates that the Lempster facility is a 24 megawatt (MW) wind-powered electric generating project located at 106 Bean Mountain Rd., Lempster, NH 03605. It consists of twelve wind turbines, each with a gross nameplate capacity of 2 MW. It is expected to commence commercial operations on or after September 1, 2008. The facility's ISO-New England asset identification number is 15115. Its NEPOOL generation information system facility code is pending.


The Commission has reviewed Iberdrola's application for the Lempster facility and determined that it has provided all the necessary information to demonstrate that the Lempster facility is eligible for certification as a Class I facility. Therefore, the Commission hereby certifies that Iberdrola's Lempster Wind LLC project is a Class I

renewable energy source effective August 29, 2008 and is eligible to be issued New Hampshire Class I renewable energy certificates.

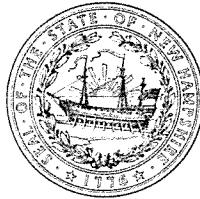

Please be advised that, pursuant to NH RSA 362-F, the New Hampshire Public Utilities Commission has certified Iberdrola Renewables, Inc.'s Lempster Wind LLC project (Lempster) as a Class I renewable energy source effective August 29, 2008. Accordingly, Lempster is eligible to be issued New Hampshire Class I renewable energy certificates.

Lempster is a 24 megawatt (MW) wind-powered electric generating project located at 106 Bean Mountain Rd., Lempster, NH 03605. It consists of twelve wind turbines, each with a gross nameplate capacity of 2 MW. It is expected to commence commercial operations on or after September 1, 2008.
