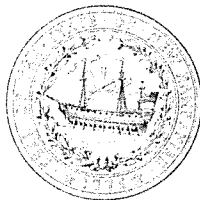

Renewal Registration as a Competitive Natural Gas Supplier

Dear Ms. Gold:

On September 29, 2008, Shell Energy North America (US), L.P. (SENA) filed with the New Hampshire Public Utilities Commission (Commission) an application for renewal of its registration as a competitive natural gas supplier (CNGS), together with a check in the amount of \$250.00. As part of its renewal application, SENA filed a \$100,000 License/Permit Bond with a term which will remain in full force until the principal seeks termination by giving thirty (30) days written notice.

The Commission has reviewed both the SENA renewal application for registration as a CNGS and the Bond Certificate submitted with the application. Its application, with the Surety Bond, meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.01. Therefore, the Commission will approve the SENA renewal application as a CNGS in the State of New Hampshire, with the registration to be effective December 1, 2008. This registration will expire at the close of business on November 30, 2010 or on the earlier termination or expiration of the Surety Bond.

Additionally, please bear in mind the following provisions of Puc 3003.01:

Pursuant to Puc 3003.01 (d), each CNGS applicant shall re-register with the Commission every 2 years by filing an application for renewal. Each CNGS applicant shall file an application for renewal at least 60 days prior to the expiration of its registration.

Pursuant to Puc 3003.01 (e), each CNGS shall include on each renewal application an update, including any changes, to all information contained in the previous application. If a CNGS fails to meet its re-filing obligation, the original registration shall expire.


Pursuant to Puc 3003.01 (i), a CNGS shall notify any LDC in whose service territory it intends to do business of the filing of its registration or renewal application at the time it files such application with the Commission.

Accordingly, SENA's application for renewal would be due October 1, 2010.

Finally, SENA filed along with its application with the Commission a Motion for the Confidential Treatment of financial information that was included as Attachment 2 of the CNGS application. The Commission will take no action on the Motion for Confidential Treatment at this time but will nonetheless treat the financial information as confidential documents and not to be made available to the public unless and until the Commission rules on the Motion for Confidential Treatment in the future.
