Beginning on Tuesday, July 31, 2007, the Short Form Standing Certificate has changed to an Internet printable document. You will be able to search, order and print a Short Form Standing Certificate from your home or office using the same Internet address you currently use, www.nj.gov/njbgs.

The new certificate will also have a new look and feel. Gone will be the blue border paper and gold seal. They will be replaced with a printed seal on standard white paper. The certificate will have the same look and feel whether you order the certificate from us over-the-counter or print it in your office.

Additionally, the new certificate will have a verification number. This will allow anyone to verify the validity of a Short Form Standing Certificate.

The one caveat is that while this Certificate is generated in real time, it will still take one business day to post annual reports. Therefore, please take this timing into consideration when ordering a Standing Certificate.
