Dear Mr. Hawkins:

On November 26, 2008, Titan Energy – New England Inc. filed with the New Hampshire Public Utilities Commission (Commission) an application for registration as a natural gas aggregator, together with a check in the amount of \$250.00.

The Commission has reviewed the Titan Energy – New England Inc. completed application for registration as a natural gas aggregator. Its application meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.02. Therefore, the Commission will approve Titan Energy – New England Inc. as a natural gas aggregator in the State of New Hampshire, with the registration to be effective January 12, 2009. This registration will expire at the end of business on January 11, 2011.

Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.02 (e), each aggregator applicant shall re-register with the Commission every 2 years by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of Titan Energy – New England Inc., on or before November 13, 2010. Pursuant to Puc 3003.02 (d), each natural gas aggregator shall notify any LDC in whose service territory it intends to do business of the filing of its registration or renewal application at the time it files such an application with the Commission. It is also noted that currently there is no provision in N.H. Code Admin. Rules Puc 3003.02 which requires a fee for the renewal of the registration as a natural gas aggregator.
