Recertification as a Class I Renewable Energy Source Pursuant to RSA 362-F

Dear Mr. Ferguson:

In response to Indeck Energy-Alexandria's (Indeck's) motion for rehearing filed on November 6, 2012, the Commission has reconsidered the timing of Indeck's recertification to produce New Hampshire Class I renewable energy credits (RECs). Upon further review of the underlying documentation it appears that Indeck was compliant with emissions requirements of RSA 362-F:11-12 throughout the second quarter of 2011. In order to give effect to Puc 2505.04(g), which requires suspension for the period of non-compliance, the "next calendar quarter" referred to in Puc 2505.04 (i) should be interpreted in this case as the next calendar quarter in which Indeck demonstrated compliance with emissions standards.

Accordingly, the Commission has revised its finding in this matter, set out by secretarial letter dated October 15, 2012, and finds that under the facts of this case Indeck should have been recertified as eligible to produce Class I RECs beginning in the second quarter of 2011.
