Dear Secretary Howland:

On behalf of Unitil Energy Systems, Inc. ("UES"), enclosed please find an original and six (6) copies of "Petition for Approval of Default Service Solicitation and Proposed Default Service Tariffs." The Petition requests that the New Hampshire Public Utilities Commission ("Commission") approve UES' solicitation and procurement, for the period beginning November 1, 2009, of 100 percent of its Default Service ("DS") requirements for its G1 customers for three months, and for 25 percent of the small customer (non-G1) DS power supply requirements for one year, and approve the proposed tariffs incorporating the results of this solicitation into rates.


