Dear Secretary Howland:

By Secretarial letter dated May 7, 2010, the Commission granted Clean Power Development's ("CPD") request to file a supplemental memorandum of law in Docket No. DE 09-067 to discuss "the impact of FERC's Order [in its Docket No. QM10-4] on the proceedings here in New Hampshire...." That Secretarial letter established May 19, 2010 as the deadline for all parties to submit supplemental memorandum of law relating to issues raised by the FERC's April 15, 2010, Order in its Docket No. QM10-4. By letter dated May 12, 2010, PSNH suggested that the filing date be delayed as the company intended to file a Request for Rehearing of the FERC Order. The Commission accepted PSNH's suggestion and by Secretarial letter dated May 17, 2010 suspended the filing deadline.

On June 11, 2010, the FERC issued the attached "Order Granting Rehearing for Further Consideration" regarding PSNH's request for rehearing.

PSNH will continue to update the Commission on the status of the FERC proceeding.
