## TO THE PUBLIC UTILITIES COMMISSION:

The Manchester Water Works, hereinafter called the "petitioner" duly organized and operating a water system under the Laws of the State of New Hampshire, respectfully represents as follows:

1. That certain persons, owners of property, in the hereinafter described part of the Town of Goffstown, said part being hereinafter referred to as the "new" service area, desire to have water service from the petitioner.

2. That there is no other water utility service water in this area.

3. That the petitioner is able and willing to supply water service in the new service area under rates on file, or to be filed, with the Public Utilities Commission.

## WHEREFORE, your petitioner prays:

- a) That the Commission find that it would be in the best interest of the public for the petitioner to engage in the business of supplying the public with water service in the Town of Goffstown as shown on the attached map.
- b) That the Commission approve a request by the Board of Water Commissioners of the City of Manchester, New Hampshire for an extension of the franchise area in Goffstown, New Hampshire to service certain franchise parcels of property over and above that established in the initial franchise order dated June, 1955, DE-3428, and subsequent orders, as follows:

The properties described as:

A block area, beginning at the intersecting point of the easterly line of Louis Street with the northerly line of Sharon Street, from this point continuing easterly in a line that is consistent with the northerly line of said Sharon Street, to the southerly most side of the Piscataquog River shoreline, thence generally north westerly, following along the southerly most shoreline of said Piscataguog River to the easterly most lot line of the Hillsborough County Farm property (Lot #33) as shown on assessors Map #6, from this point turning southerly and following the easterly lot line of said County Farm property, as shown on assessors Map #6, Lots 33 and 35, to the northerly side of Mast Road, and connecting with existing franchise limit for said Mast Road, from this point, turning easterly and following along the northerly side of Mast Road and existing franchise limits to the westerly side of Moreau Street, thence northerly along the westerly side of Moreau Street to its dead end at the southerly line of Lot 58 as shown on assessors Map #17, thence easterly to the westerly side of Rochambeau Avenue, thence northerly along the westerly side of Rochambeau Avenue to a point that is in line with the westerly line of Sharon Street, thence easterly along

the northerly side of said Sharon Street to the point of beginning.

Meaning and intending, for the purpose of supplying water service, a block area bounded on the <u>north</u> by the southerly most shoreline of the Piscataquog River, on the <u>south</u> by the northerly most side of Mast Road, on the <u>east</u> by the westerly lot line of the Goffstown Landfill site, and all existing franchise limits between Mast Road and the southerly side of the Piscataquog River shoreline, and on the <u>west</u> by the easterly most lot line of the Hillsborough County Farm property, with the above more specifically shown on a map entitled, entitled "City of Manchester, N.H., Manchester Water Works, Exhibit #1, Proposed Franchise Extension, Lynchville Park Area, Goffstown, N.H.", dated April 3, 2009, hereto attached and made a part of this request for franchise extension.

c) This proposed franchise extension is meant and intended for the purpose of supplying potable water by the Manchester Water Works to the area within the notice of request.

4. That the area under request for a franchise extension would be subject to the terms of the Merrimack Source Development Charge as approved under Order No. 18,628 by the Public Utilities Commission, dated April 6, 1987, effective May 1, 1987, and as amended under Order No. 20,332 by the Public Utilities Commission, effective December 12, 1991.

5. That the Commission, by appropriate order, grant, to the Petitioner, permission and approval to exercise all rights necessary to engage in business as a public utility and to begin construction of a plant, line or other apparatus or appliances in the new service area.

6. That the Commission make such further findings and orders as may be appropriate in the circumstances.

The Manchester Water Works has also attached authorization of the above referenced project by the Goffstown Town Council.


