The Commission issued an Order of Notice on July 6, 2009 in the above-captioned docket scheduling a prehearing conference for July 23, 2009. The following parties attended the prehearing conference: Public Service Company of New Hampshire (PSNH), the Office of Consumer Advocate (OCA), Bill Gabler from Clean Power Development (CPD), who filed a motion to intervene in this docket, and Commission Staff. The Commission heard from the parties and Staff regarding CPD's motion to intervene and took the matter under advisement.

Following the prehearing conference, the parties and Staff met in technical session. We developed the following proposed procedural schedule for the Commission's consideration. We also agreed that the parties and Staff can submit rolling data requests to PSNH through August 14, 2009, thus allowing for a second set of data requests before that date if necessary.
