Re: **Quarterly Emissions Verification Summary for Certified Renewable Energy Sources (Dockets DE 08-024, DE 08-044, DE 08-051, DE 09-008, DE 09-104, and DE 12-091) New Hampshire Certification Code NH-IV-13-020**

Dear Mr. Webb:

Pursuant to RSA 362 F-:11, III, eligibility determinations of generation facilities that use biomass fuels are conditional. Within ten days of receiving the quarterly notice from the New Hampshire Department of Environmental Services (DES) that the facility has met DES emissions standards, the Commission must designate the facility as eligible to produce Renewable Energy Certificates.

Based on the DES recommendation, the Commission hereby certifies the following wood-fired power plants as renewable energy sources for the fourth quarter of 2012, as the facilities meet average emission rates of 0.02 lb/MMBtu and 0.075 lb/MMBtu, for particulate (TSP) and nitrogen oxides (NOx), respectively:
