The current rules governing this conduct are to expire in 2010. The PUC intends, therefore, to readopt the rules, and to include revisions and updates to the registration and reporting requirements for competitive energy suppliers and aggregators of electricity load.

6. (b) Brief description of the groups affected:

The rules and amendments will affect competitive energy suppliers and aggregators of electricity load and may also affect electric power generators and electric power distribution utilities and the customers of these entities.
