On October 26, 2009, FairPoint Communications, Inc. and its affiliated entities (FairPoint) filed for voluntary reorganization under Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the Southern District of New York. On October 30, 2009, Fairpoint filed a petition regarding all pending dockets involving FairPoint requesting that the Commission extend mandatory filing and appearance requirements and deadlines between October 26, 2009 and November 13, 2009 by 21.

days and establish no new deadlines for effect prior to November 16, 2009. On November 2, 2009, Commission Staff members Kate Balley and Anne Ross filed a recommendation in support of FairPoint's petition. On November 6, 2009, they filed a further recommendation for a longer stay of certain other dockets involving Fairpoint. With regard to the filings required by Commission Order No. 24,823 (February 25, 2008), the Commission issued a scretarial let-ter dated November 10, 2010 granting the request for a 21-day extension, with the exception that specified daily status reports continue to be filed. In addition, the petition was denied to the extent that it was intended to apply to routine com-munications between FairPoint and Commission Staff concerning issues related to the provision of safe and reliable service. In the same letter, the Commission indicated that Ms. Bailey and Ms. Ross would be treated in the manner of staff advocates in relation to Commission matters directly affecting or directly affected by the Company's reorganization plan.

On February 11, 2010, FairPoint filed with the Bankruptcy Court its First Amended Joint Plan of Reorganization under Chapter 11 of the Bankruptcy Code and related proposed Amended Disclosure Statement. On February 12, 2010, FairPoint filed copies of the same with the Commission. As part of the Reor-ganization Plan, a Regulatory Settlement applicable to the State of New Hampshire between Staff Advocates and FairPoint

was filed as Exhibit E. On February 24, 2010, FairPoint filed with the Commission a petition request-ing certain approvals in connection with the Reorganization Plan. In support of the petition, FairPoint filed pre-filed direct testimony and exhibits of Alfred C. Glam-marino, Jeffrey W. Allen, Vicky Weatherwax, Bryan Lamphere, Thoms P. Nolting and Richard Murtha. In the petition, Fair-Point requests that the Commission:

1. Make a finding pursuant to Puc 203.20 that the Regulatory Settlement is just and reasonable and serves the public interest and approve the same;

2. Determine pursuant to RSA 369:8,II(b) that the change in control of FairPoint Communication, Inc., as parent company of FairPoint Communica-tions-NNE and Northland, will not have an adverse effect on the public utility rates, terms service or operation of Fair point communications-NNE or Northland within New Hampshire;

3. Pursuant to RSA 365:28, approve the modifications to the settlement agreement approved in Order No. 24,823 (February 25, 2008), as set forth in the Regulatory Settlement;

4. Pursuant to RSA 369:2, approve the pledge by FairPoint Communications-NNE of its membership interests of VT Telco: and
