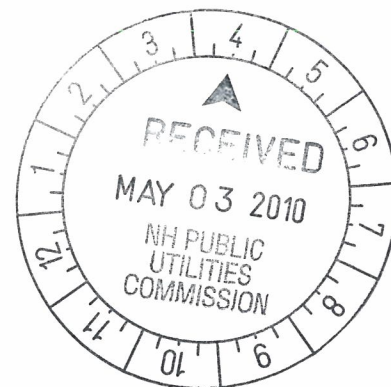


Dear Secretary Howland:
