

TERMS OF PAYMENT:


This Surcharge will be in effect for each customer for a total of one (1) monthly billing period per customer commencing December 1, 2010 or until the rate case expenses of \$10,188 are collected, which ever is earlier. Bills under this rate are net and will be rendered monthly and are due and payable upon presentation. All accounts twenty five (25) days past due will be assessed a late fee of Ten Dollars (\$10.00) at the discretion of the Company.
