Dear Ms. Howland:

This letter is supplemental to Staff's recommendation submitted on February 14, 2011 relative to West Swanzey Water Company, Inc.'s (WSWC) recovery of rate case expenses in Docket DW 10-159. In its prior correspondence, Staff recommended that WSWC should be allowed to recover a total of \$8,128.80 in rate case expenses from 76 customers over 8 billing quarters. This would amount to a \$13.37 quarterly surcharge per customer over that period of time.

Today, WSWC submitted an additional invoice in the amount of \$238.15 for services rendered by the court reporter in that case. A copy of this invoice is attached to this correspondence. WSWC has requested that this cost be included in its recovery of rate case expenses in this docket. Staff has examined the supporting invoice relative to this expense and concurs with WSWC's request that it be included in the recovery of rate case expenses. Staff and WSWC are now recommending recovery of a total of \$8,366.95 from 76 customers over 8 billing quarters. The revised quarterly surcharge that is being recommended amounts to \$13.76 per customer per quarter ($$8,366.95 \div 76$ customers $\div 8$ quarters).

As indicated in Staff's prior recommendation, WSWC and Staff propose that the Commission's decision regarding rate case expenses be included in its order regarding the proposed Stipulation Agreement presented in this case.
