## STIPULATION AND SUPPLEMENT TO PROGRAM YEAR 2012 PARTIAL SETTLEMENT AGREEMENT

The following sentence shall be added after the last sentence of Section III. G, entitled "Gas Utilities Carry-Over and Impact on LDAC for Winter 2012-2013," on pages 5 and 6 of the Program Year 2012 Partial Settlement Agreement:

> "The Companies may also utilize the budget transfer process between individual programs as described on page 18 of the 2011-2012 filing of the electric utilities dated August 1, 2010, entitled "Changes in Program Budgets," and page 10 of the 2011-2012 filing of the natural gas utilities dated August 2, 2010, entitled "Reallocation of Budgets," and as approved by the Commission in Order No. 25,189 in DE 10-188, dated December 30, 2010, pages 21 and 22."
