

We, the business and civic leaders of our community, fervently appeal to the PUC to approve the Laidlaw Berlin BioPower PPA without delay. Without question the Laidlaw project addresses the broad economic, business and employment needs of the North Country along with the overall economic development and well being of the entire State of New Hampshire. This project is critical to the development of renewable energy and would act as a catalyst and springboard to the development of many businesses on the available 120 acre industrial former mill site as well as other locations throughout the community. The future of the community and the state will be impacted by your decision.

The current economic climate has created many significant challenges. Over the last four years we have closely followed the development of this project and are convinced that this is a great opportunity for the region.
