1	PROCEEDING
2	CHAIRMAN GETZ: Okay. Good afternoon,
3	everyone. We'll open the prehearing conference in Docket
4	DT 10-211. On August 10, 2010, NeuStar, Inc., North
5	American Numbering Plan Administrator, filed a petition
6	requesting approval of a relief plan for the 603 area
7	code, also known as the 603 Numbering Plan Area.
8	According to NANPA projections, without relief, the supply
9	of NXX codes in the 603 NPA will be exhausted during the
10	third quarter of 2012. We issued an order of notice on
11	October 15 that, among other things, explained some of the
12	background for relief planning that has taken place in New
13	Hampshire since 1999, and indicates various measures that
14	have been taken to extend the life of the existing 603
15	NPA. The order of notice also indicates that NANPA
16	conducted an industry conference call on June 30, 2010,
17	and the recommendation for relief is an all-services
18	distributed overlay for the 603 area code. The new area
19	code would be superimposed over the same geographic area
20	covered by 603, and all existing customers would retain
21	the 603 area code and would not have to change their
22	telephone numbers. That relief plan, however, would
23	require 10-digit dialing for all calls within and between
24	the 603 NPA and the new NPA.

1	I note for the record that the affidavit
2	of publication was filed on October 26. We have a letter
3	from the Office of Consumer Advocate noting its
4	participation in this proceeding. We also have Petitions
5	to Intervene from FairPoint Communications, Verizon
6	Wireless, Verizon Access Transmission, Time Warner Cable,
7	BayRing, the New Hampshire Telephone Association,
8	T-Mobile, and Level 3 Communications. I believe that's
9	all the petitions that I have before me.
10	But, at this point, let's take
11	appearances by the parties that are here. If there's
12	anyone else who is seeking to intervene, please indicate
13	so. And, turn to Mr. Fossum, my understanding is that on
14	the phone we have persons from NeuStar or NANPA?
15	MR. FOSSUM: Yes. There are at least
16	one person, and probably more on the phone, from NANPA.
17	It was determined that, essentially, as a cost-saving
18	measure, that NANPA would not be here in person. But I
19	have been given authorization to read a short statement on
20	their behalf, at the time that the Commission deems
21	appropriate for NANPA to enter a position.
22	CHAIRMAN GETZ: Okay. Thank you. Then,
23	let's begin the folks that are here, starting in the
24	front. Sir, do you have an appearance?

6	MR. FOSSUM: And, good afternoon.
7	Again, Matthew Fossum, for the Staff of the Commission.
8	And, with me today are Kate Bailey, Michael Ladam, and
9	David Goyette from Commission Staff.
10	CHAIRMAN GETZ: Okay. Good afternoon.
11	Well, let me address this issue. Are there any objections
12	to Petitions to Intervene, before we
13	MR. TRACHY: Mr. Chairman, I just I
14	thought you were asking us to speak, and we're not
15	speaking. Stuart Trachy and Owen Smith, with AT&T. But
16	we're not speaking.

20	CHAIRMAN GETZ: Okay. Thank you. Are
21	there any objections to any of the Petitions to Intervene?

24	objection, and recognizing that the parties have

2	proceeding, we're going to grant all of the Petitions to
3	Intervene. And, before we well, first off, Mr. Fossum,
4	why don't we get the NeuStar position on the record, then
5	we'll hear comments from everyone else. And, I think the
6	Commissioner has Commissioner Below has a question he'd
7	like to pose to the parties. So, if you could
8	MR. FOSSUM: Certainly. As I said, I
9	was authorized yesterday to make this statement on behalf
10	of the NANPA.
11	And, the statement reads as follows:
12	"NeuStar, Inc., in its role as the North American
13	Numbering Plan Administrator, submitted the Petition for
14	relief of the 603 area code on behalf of industry members.
15	As a neutral third party administrator, NeuStar has no
16	opinion regarding the Commission's decision in this
17	docket."
18	CHAIRMAN GETZ: Okay. Thank you.
19	MR. FOSSUM: That's all.
20	CHAIRMAN GETZ: Commissioner Below.
21	CMSR. BELOW: And, I would just like to
22	ask the parties, when they state their initial position,
23	if they have any thoughts as to anything they might be
24	able or willing to do or other suggestions to buy some

1 more time for implementation of a change. Such as, last 2 time around this, we bought over a decade's worth of time 3 by shifting the numbering block size, for instance, from 10,000 numbers to 1,000 number blocks. And, we know 4 5 there's a lot of blocks out there that aren't fully 6 utilized, but may be somewhat utilized, so they're 7 contaminated. And, I guess the question for the 8 9 parties is do they have any thoughts as to any efforts 10 that might be undertaken to utilize the numbers that are 11 out there, either to create more options or even just to buy time for the implementation or phase-in of whatever 12 13 action is decided upon? Thank you. 14 CHAIRMAN GETZ: Okay. Then, if you've 15 had enough time to digest that, Mr. Moore, you spoke 16 first, so you can state the position of your clients. 17 MR. MOORE: Thank you, Mr. Chairman. 18 Verizon Access Transmission is here to support the NeuStar In our view, should the Commission determine 19 proposal. 20 that a new area code is necessary, the most reasonable and 21 efficient way to address that is to do the full overlay. The Commission, of course, will have to balance a number 22 23 of different concerns. But we believe that, for most 24 customers, most of the time, it's the least disruptive to

1	have the overlay, rather than, say, a split of the state
2	into different area codes.
3	The other point I wanted to make is that
4	NeuStar has proposed a 17-month time period following the
5	Commission's decision to implement a new area code. We
6	think that is important, both to allow carriers to, you
7	know, make the adjustments they need in their networks to
8	accommodate the change, and also to provide sufficient
9	notice in time for consumers to get used to the change,
10	whatever it may be.
11	I have to say, in response to
12	Commissioner Below's questions, we don't we haven't
13	developed any particular notions or thoughts about whether
14	there are still additional steps that you could take to
15	forestall the exhaust of the current area code. Thank
16	you.
17	CHAIRMAN GETZ: Okay. Thank you.
18	Ms. Nelson.
19	MS. NELSON: Thank you very much, Mr.
20	Chairman, members of the Commission. Verizon Wireless
21	also supports the NeuStar petition, both with respect to
22	the overlay as the superior form of relief and the
23	17-month implementation period. We believe that the
24	overlay relief plan will best serve the interests of all

1	consumers, residential and commercial, across New
2	Hampshire, by providing the least disruption to all
3	businesses and personal interests.
4	I do have a brief statement setting
5	forth our petition in somewhat greater detail, which I'd
6	be glad to have marked and have part of the record.
7	And, with respect to the issue posed by
8	Commissioner Below, I'd be glad to confer further with my
9	client, particularly in the technical session, which I
10	gather is going to follow this prehearing conference, to
11	discuss that issue in more detail with them.
12	CHAIRMAN GETZ: Okay.
13	MS. NELSON: I guess I would ask the
14	Commission, would you like me to mark this now or at the
15	end of the prehearing?
16	CHAIRMAN GETZ: Well, I think you can
17	submit it. I don't think we need to mark it as an exhibit
18	at this point. And, you can file it with the Clerk and
19	we'll make it part of the record.
20	MS. NELSON: Thank you very much.
21	CHAIRMAN GETZ: And, then, I expect
22	there will be discussion at the technical session
23	following up, as you say, about some of the issues raised

2	Mr. Chairman. FairPoint and NHTA take no position on
3	NeuStar's petition, other than to say that, to the extent
4	the Commission believes that relief is necessary, we
5	support an overlay solution, as opposed to a split.
6	And, we have no thoughts on Mr. Below's
7	or, Commissioner Below's question at this time. Thank
8	you.
9	CHAIRMAN GETZ: Thank you. Mr. Patch.
10	MR. PATCH: Mr. Chairman, I'd request
11	leave to be able to consult with my client further on
12	their position. I'm not sure exactly what, if they have a
13	position at this point in time, what it is. And, I'd be
14	happy to submit that to the Commission, if that would be
15	useful. But just haven't had a chance to formulate that
16	yet.
17	CHAIRMAN GETZ: Okay. I think, as it
18	develops, as the proceeding goes forward, then they can
19	make their position known.

22	MR. WINSLOW: BayRing takes no position
23	at this time. And, we don't have any additional thoughts
24	on whether or not we can delay implementation any further.

4	The OCA also has no position at this time. And, we don't
5	have specific proposals in response to Commissioner
6	Below's question. But we will certainly work with the
7	parties and Staff to try to explore those.
8	CHAIRMAN GETZ: Thank you. Mr. Fossum.
9	MR. FOSSUM: Thank you. Staff also has
10	no position on the petition at this time. And, we'll be
11	working with all the interested parties to formulate the
12	best possible record on which the Commission can base its
13	decision.
14	As to Commissioner Below's point, I do
15	want to bring up that Staff has been made aware only very
16	recently, and I mean within the last 12 hours or so, that
17	NANPA has revised its exhaust estimate for New Hampshire.
18	In the Petition, it was noted that exhaust was estimated
19	for the third quarter of 2012. It has now been revised
20	the revised estimate puts it at the second quarter of
21	2013. So, there already has been at least one revision to
22	that exhaust. We will certainly be discussing that
23	development and other relevant issues with the remaining
24	with all the parties in the technical session to
