Re: DE 10-212, Commercial and Industrial Renewable Energy Incentive Program  
Request for Clarification or Modification of Program Category 2 Maximum  
Eligible Project Capacity Size

To Whom It May Concern:

On October 1, 2010, the Commission approved a commercial and industrial solar energy incentive program (C&I incentive program) supported by the Renewable Energy Fund created by RSA 362-F:10. *See* Order No. 25,151, dated October 1, 2010. On February 20, 2015, the Commission issued Order No. 25,764, which approved an expansion and modification of the C&I incentive program (Modification Order).

In a memorandum dated April 13, 2015, Commission Staff described the request made by a developer representative to have the Commission clarify or modify the approved program term that sets a maximum project capacity size of 500 kilowatts (AC) for Category 2 of the C&I incentive program. Staff recommended that the Commission decline to clarify or modify the maximum project size program term as requested, citing several reasons for its recommendation.

The Commission has considered the request for program term clarification or modification, Staff's recommendation regarding the request, and the reasons supporting Staff's recommendation. The Commission has determined that there is nothing unclear or ambiguous on this issue that needs clarification, and that there is no basis for modification. The Commission has therefore denied the request. Accordingly, the maximum capacity size for eligible projects under Category 2 of the C&I incentive program remains 500 kW (AC), as approved in the Modification Order.
