Dear Ms. Howland:

On behalf of EnergyNorth Natural Gas, Inc. d/b/a National Grid NH (the "Company") and in accordance with New Hampshire Public Utilities Commission Order No. 25,161, dated October 28, 2010 Docket DG 10-230, I enclose seven copies of the Company's adjusted 2010-11 Winter Cost of Gas rates to be effective April 1, 2011. These adjusted rates require no further Commission action because they are within maximum rates set forth in the Order No. 25,161.

The adjusted cost of gas rates are being filed to reflect an update of the winter period deferred gas cost balance and the projected commodity prices for the remainder of the winter period. The attached estimated cost of gas was calculated using the 8 day average NYMEX settle prices as of March 23, 2011. Accordingly, these adjustments decrease the average cost of gas rate by \$0.0358 per therm. Specifically, the Residential Cost of Gas rate is decreased from \$0.8348 per therm to \$0.7990 per therm. Similarly, the Commercial/Industrial Low Winter Use rate is decreased from \$0.8314 per therm to \$0.7956 per therm, and the Commercial/Industrial High Winter Use rate is decreased from \$0.8362 per therm to \$0.8004 per therm.

The calculation indicates that absent the adjustment there would be an estimated over collection of gas costs as of April 30, 2011 of approximately \$288,464 or -0.45%.
