To the Parties:

On January 13, 2012, Staff submitted a request to modify the procedural schedule in the above referenced proceeding. The request states that there are, among other things, outstanding Motions to Strike that need to be resolved and recommends that the January 18 and 19, 2012 hearings be rescheduled to April 4 and April 5, 2012. Staff represents that most parties concur with the request, but the Sierra Club opposes the rescheduling of the hearings and the New England Power Generators Association takes no position.

The Commission has determined that the proposed revision is in the public interest and therefore has approved it. The hearings on the merits are rescheduled to April 4 and 5, 2012 at 10:00 a.m.
