

Withdrawal of Registration as Competitive Natural Gas Supplier

Dear Ms. Barnes:

On July 24, 2014, you filed a request with the Commission to withdraw the registration of South Jersey Energy Company (South Jersey) as a Competitive Natural Gas Supplier (CNGS) as of June 30, 2014. In your letter you stated that South Jersey has not served any natural gas customers during the past 90 days.

The Commission's rules governing CNGS do not provide for the rescission or abandonment of a CNGS registration. The Commission has reviewed your letter and has deemed it a request for waivers of N.H. Code Admin. Rules Puc 3003.01(f) (approved CNGS registration valid for five years), and Puc 3003.01(h) (CNGS to continue compliance with requirements of Puc 3000). The Commission has determined that the requested waivers, without any further conditions, are in the public interest because the waivers will not disrupt the orderly and efficient resolution of matters before the Commission, and the purpose of the rules will be satisfied by the orderly termination of South Jersey's CNGS registration.

Accordingly, South Jersey's CNGS registration is deemed withdrawn and terminated, effective as of June 30, 2014.
