Dear Ms. Howland:

I am writing to follow up on my letter of October 10, 2014 regarding the release of the remaining Pool A Escrow Funds held pursuant to the Escrow Agreement dated July 3, 2012 between National Grid and Bank of America, as Escrow Agent, upon the occurrence of Day N in accordance with the settlement approved by the Commission in its Order No. 25,400. Enclosed is a Disbursement Request form signed on behalf of National Grid USA relating to the final \$1,500,000 of Pool A Escrow Funds. The remaining documents relating to certification of the occurrence of Day N and release of the related escrow funds were included with my October 10 letter.

Pursuant to the Agreement Regarding Process for Release of Escrow Funds dated July 20, 2012, National Grid requests that the Commission's General Counsel execute the enclosed Disbursement Request and return the original to me to authorize release of the \$1,500,000 of Pool A Escrow Funds being held pending the occurrence of Day N. Please note that the Disbursement Request form is a confidential document, as determined by the Commission in its Order No. 25,400, and therefore is being provided in a separate envelope. A redacted form of the Disbursement Request form is also enclosed and is the only form of that document that is being provided to the individuals on the service list other than the Consumer Advocate.
