Dear Ms. Howland:

On behalf of EnergyNorth Natural Gas, Inc. d/b/a National Grid NH (the "Company") and in accordance with New Hampshire Public Utilities Commission Order No. 25,217, dated April 29, 2011 Docket DG 11-046, I enclose an original and six copies of tariff pages and accompanying calculations setting forth the Company's adjusted 2011 Summer Cost of Gas rates to be effective July 1, 2011. These adjusted rates require no further Commission action because they are within the range set forth in Order No. 25,217.

The adjusted cost of gas rates are being filed to reflect an update of the summer period deferred gas cost balance and the projected commodity prices for the remainder of the summer period. The estimated cost of gas was calculated using the 15 day average NYMEX settle prices as of June 23, 2011. Accordingly, these adjustments increase the average cost of gas rate by \$0.0183 per therm. Specifically, the Residential Cost of Gas rate is increased from \$0.7429 per therm to \$0.7612 per therm. Similarly, the Commercial/Industrial Low Winter Use rate is increased from \$0.7359 per therm to \$0.7542 per therm, and the Commercial/Industrial High Winter Use rate is increased from \$0.7468 per therm to \$0.7651 per therm.

The calculation indicates that absent the adjustment there would be an estimated under collection of gas costs as of October 31, 2011 of approximately \$250,202 or 1.63%.
