Dear Ms. Howland:

I enclose one copy of Public Service Company of New Hampshire's reconciliation of Stranded Cost Recovery Charge (SCRC) and Energy Service (ES) revenues and expenses for the interim period January 1, 2012 through March 31, 2012. In the Stipulation and Settlement filed in Docket DE 02-127, PSNH, the Office of Consumer Advocate and Staff agreed that PSNH would make preliminary quarterly filings reconciling SCRC and ES revenues and expenses.

The preliminary results for the first quarter of 2012 indicate the following:

- (1) The SCRC expenses have exceeded SCRC revenues resulting in an under recovery of approximately \$4.2 million, as shown on page 1 of the attached filing.
- (2) The ES expenses exceeded ES revenues resulting in an under recovery of approximately \$5.9 million, as shown on page 6 of the attached filing.
