On October 24, 2011, a duly noticed prehearing conference was held in the above referenced proceeding. Appearances at the prehearing conference were entered by representatives of Granite State Electric Company d/b/a National Grid and Commission Staff. The Office of Consumer Advocate has a statutory right to intervene in the proceeding but chose not to at this time. There were no interventions.
