

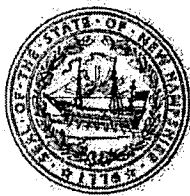

Re: **Response to Preliminary Objection to FP 2013-51**
Puc 400 Rules for Telephone Utilities
PUC Docket No. DRM 12-036

Dear Chairman Reagan:

I write to you as Chairman of the Public Utilities Commission (Commission) in response to the Committee's preliminary objection to Final Proposal 2013-51 regarding the Puc 400 rules relative to telephone utilities. The preliminary objection was entered on January 17, 2014 by vote of the Committee, pursuant to RSA 541-A: 13, IV, based on public testimony presented at the Committee's meeting on that date by the New England Cable and Telecommunications Association, Inc. (NECTA), Comcast Phone of New Hampshire, LLC (Comcast), and the New Hampshire Telephone Association (NHTA).

In order to address the Committee's preliminary objection, Commission Staff held meetings with representatives of NECTA and Comcast and with representatives of NHTA to discuss potential approaches to resolution of the objections and concerns expressed in their public testimony. I am pleased to report that these discussions were successful in resolving the relevant issues such that no public commenter is pursuing any further objection to Commission adoption of the amended rules. NECTA and Comcast have confirmed that they have no remaining objections. NHTA has confirmed that it has withdrawn its objections to adoption of the amended rules, but reserves the right to challenge specific provisions in other forums.

The resolutions which address these objections and concerns, as well as certain editorial revisions, are incorporated in the amended version of the Commission's Puc 400 rules enclosed herewith. The text of these revised rules was approved by the Commission at a public meeting held on March 3, 2014.



In particular, the concerns raised by NECTA and Comcast have been addressed through the addition of a new Part Puc 413 (Registration of Telecommunications Carriers for Recognition of Rights and Obligations under Federal Law), which necessitated corresponding language revisions in Puc 401.01 (Purpose) and Puc 401.02 (Application). Concerns raised by NHTA have been addressed through revisions to Puc 405.05 (Number Portability Notice), Puc 406.02 (Emergency Operations), Puc 410.03 (Basic Service), and Puc 410.04 (ILEC Discontinuations of Basic Service). With these revisions, the Commission believes that the rules have been amended to remove the basis for the objections and concerns expressed by NECTA, Comcast and NHTA.

The Commission respectfully requests that the Committee approve the revised rules submitted with this response without further amendment or revised objection. Thank you for your attention to this matter.
