SUPPLEMENTAL ORDER OF NOTICE

On February 2, 2012, a Request for Advance Comment on a Subject Matter of Proposed Rulemaking concerning New Hampshire Code of Administrative Rules PART Puc 400 — Rules for Telephone Service was published in the New Hampshire Rulemaking Register. That notice provided for a public comment session on April 17, 2012 and for written comments to be accepted until June 13, 2012. At the April 17, 2012 public comment session commenters indicated that it would be beneficial to extend the written comment period to allow additional time for commenters to incorporate possible legislative changes. On May 17, 2012 a new Request for Advance Comment on a Subject Matter of Proposed Rulemaking concerning New Hampshire Code of Administrative Rules PART Puc 400 — Rules for Telephone Service was published in the New Hampshire Rulemaking Register. The new request is appended to this Order of Notice. The new request provides that Commission Staff will be accepting comments relating to PART Puc 400 through the close of business on July 6, 2012 but is otherwise unchanged from the prior notice. The comments are being accepted for purposes of informing the Commission on the production and adoption of an Initial Proposal.

Pursuant to RSA 541-A:6, III, this order of notice shall be sent to all those regulated by these rules and those who have made a request for notice of rulemaking proceedings. In addition, this notice will also be published in a publication of daily statewide circulation.

6. (a) Summary of the subject matter, or summary of the rule if drafted, and the effect on those regulated:

This notice is provided for the purpose of extending the deadline for comments on a subject matter of possible rulemaking from June 13, 2012 to July 6, 2012. The notice is otherwise unchanged from the notice published in the February 3, 2012 Rulemaking Register, except that a second hearing is not scheduled.

The rules set forth definitions of terms, general rules, rights and obligations, and statutory and other requirements, including requirements for: registration and reporting; the filing and maintenance of tariffs and rate schedules; certain intercarrier relationships; customer relations and consumer protections; and public safety and emergency response.

In addition to readopting the above, and in light of substantial changes at the local, state and national levels, the rules will also address, to the extent necessary, requirements for other items, including: rights and obligations imposed, altered or eliminated by the United States Congress and Federal Communications Commission; and additional or modified requirements for the preservation of universal service, protection of public safety and welfare, ensuring the continued quality of telecommunications services and safeguarding the rights of consumers in a competitive environment. The readopted rules will also focus on streamlining the existing rules to limit redundancies.

6. (b) Brief description of the groups affected:

Any person or entity that provides or will provide regulated telephone service in New Hampshire as defined in the rules, and customers of such providers.
