# AMENDMENT NO. 1

## Service Agreement for Digital Centrex Service

This Amendment of Service Agreement for Digital Centrex Service ("Agreement") is made this 2nd day of November 2011 by and between Northern New England Telephone Operations LLC DBA FairPoint Communications-NNE with offices at 521 East Morehead Street, Ste. 500, Charlotte, NC 28202, and [REDACTED] with offices [REDACTED]

[REDACTED] ("Customer") (hereinafter together "the Parties").

WHEREAS, FairPoint Communications-NNE and Customer are Parties to that Service Agreement dated March 11, 2009, desire to amend the terms of the Agreement as described therein and as set forth below.

NOW, THEREFORE, for good and valuable consideration the sufficiency of which is hereby duly acknowledged, the Parties amend the Agreement as follows:

- 1) Exhibit A - modify the Monthly Line Rate for lines located [REDACTED] to \$14.40 per line. The Monthly Line Rate does not include EUCL. The current EUCL rate is \$6.14 and subject to change. The above Monthly Line Rate will not be effective until Public Utilities Commission (PUC) approval. Modify the quantity of lines to 464.
- 2) Exhibit A - extend the Service Period an additional thirty-six (36) months from the last signature date of this amendment.
- 3) Exhibit B - modify the Monthly Line Rate for lines located [REDACTED] to \$11.75 per line. The Monthly Line Rate does not include EUCL. The current EUCL rate is \$6.14 and subject to change. The above Monthly Line Rate will not be effective until PUC approval. Modify the quantity of lines to 441.
- 4) Exhibit B - extend the Service Period an additional thirty-six (36) months from the last signature date of this amendment.
- 5) All other rates, terms and conditions as set forth in the Agreement shall remain the same.

NOW, THEREFORE, for good and valuable consideration the sufficiency of which is hereby duly acknowledged, the Parties amend the Agreement as follows:

- 1) Exhibit B - Section 1: modify the Monthly Line Rate for lines located [REDACTED] to \$24.57. The monthly line rate of \$24.57 is inclusive of the Exchange Usage charge. The Monthly Line Rate does not include EUCL. The current EUCL rate is \$6.14 and subject to change.
- 2) Exhibit B - Current inventory of lines is 524.
- 3) Exhibit B - change the type of Service from Digital Centrex to FairPak Centrex lines.
- 4) Exhibit A - Modify the initial quantity of lines set forth in Section 1 from 680 to 586. Current inventory of lines is 538. Change minimum quantity of lines set forth in Section 4 ("Minimum Line Obligation, Commitment Amount") from 476 to 410.
- 5) All other rates, terms and conditions as set forth in the Agreement, as previously amended, shall remain in full force and effect.
