Dear Mr. Bogdan:

On June 1, 2012, Broadview Networks, Inc. submitted proposed rate changes to revise its intrastate access rates to comply with the requirements of the Federal Communications Commission (FCC) in its order, Connect America Fund et al., WC Docket No. 10-90 et al., Report and Order and Further Notice of Proposed Rulemaking, 26 FCC Rcd 17663 (2011). The proposed revisions address the requirement that carriers reduce their intrastate access revenues.

Staff reviewed these revisions and concluded that they are consistent with the FCC's requirements. The Commission has accepted Staff's recommendation that the rates conform to the requirements of the FCC's order. Pursuant to RSA 378:3 and RSA 378:6, IV, the revision has gone into effect by operation of law on July 1, 2012.
