



I. Statement of Interest.

SegTEL is a facilities-based competitive local exchange carrier (CLEC) currently operating in New Hampshire pursuant to Commission Order No. 23,208 issued on May 3, 1999 in Docket No. DT 99-048.

SegTEL's rights to purchase certain UNEs under section 251 of the Telecommunications Act of 1996 as modified by the Triennial Review Remand Order (TRRO) may be substantially affected by this proceeding.
