On behalf of my firm, George E. Sansoucy, P.E., LLC, and myself I petition the N. H. Public Utilities Commission (NHPUC) for permission to intervene in this proceeding for the following reasons:

1. Through my firm, I have provided utility valuation services and advice on utility taxation issues to a large number of cities and towns in New Hampshire and I have a continuing relationship with many of them.


2. Many of the communities with whom I have a relationship have limited staff resources or are not themselves knowledgeable about matters relating to regulated utilities. I anticipate that I will be called upon to offer knowledge and advice to a number of them.
