To the Parties:

On March 7, 2008, Commission Staff filed a recommendation regarding utility interconnection standards pursuant to Commission Order No. 24,919 (January 22, 2008) in the above referenced proceeding. Staff proposed that the Commission direct the parties to work toward the implementation of interconnection standards similar to the Massachusetts Interconnection Standards for projects of 10 kVA or less. In the interim, Staff recommends the continued use of the existing interconnection standard.

The Commission has scheduled a technical session on April 25, 2008 at 10:00 a.m., to provide the parties an opportunity to discuss Staff's recommendation and the report of Liberty Consulting Group which was attached thereto.
