#### INITIAL COMMENTS OF HUNT TECHNOLOGIES, INC.

AND NOW COMES Scott H. DeBroff, Esquire of Smigel, Anderson, & Sacks LLP on behalf of his client, Hunt Technologies, Inc. ("Hunt"), for the purpose of these "Initial Comments" on the Time Based Metering and Communications Standards with respect to this docket of the New Hampshire Public Utilities Commission ("NHPUC" or the "Commission") regarding the investigation into Implementation of Federal Standards of The Domenici-Barton Energy Policy Act of 2005 and avers the following:

1. Hunt Technologies, Inc. ("Hunt") is a party in the above-captioned docket and is a meter technology provider which has participated extensively in rulemaking proceedings in other states involving the implementation of the Energy Policy Act of 2005, specifically addressing the Smart Metering and Demand Response provisions beginning at Section 1252 of the Electricity Title of the Act.

2. Hunt Technologies delivers industry-leading advanced metering infrastructure (AMI) solutions to the electric, water and natural gas utilities markets. Based in central Minnesota, Hunt develops and supports hardware and software for more than 480 customers worldwide.

3. On August 8, 2005, President Bush signed the Energy Policy Act of 2005 into law. EPACT 2005 amends PURPA and requires state regulatory authorities, with respect to electric utilities, to consider and make a determination regarding net metering, smart metering, cogeneration and small production purchase and sale requirements and interconnection.

4. The above-captioned Investigation proceeding was docketed by the Commission and an Order setting a date for a Pre-Hearing Conference and a Technical Session to discuss the Investigation and establish a proposed procedural schedule was filed on April 24, 2006.

5. On May 16, 2006, a Pre Hearing Conference was held at the Commission and a transcript of such was filed on May 31, 2006.

6. On June 6, 2006, a Letter of three outlines of discussion topics to consider the five new Federal standards was submitted to the Commission and other documents were subsequently filed on July 13, 2006.

7. On July 25, 2006, the Staff's Recommendation was filed to the docket.

8. Regarding whether the Time Based Metering and Communications standards should be implemented, we believe that the promotion of the federal standard will provide benefits to the ratepayer as well as provide operational efficiencies to New Hampshire's utilities in the process. We also are supportive of a strong alignment to the Federal standards when promotion of such

policy also includes language that advanced metering technologies should be deployed if they reduce the utilities' costs and will not increase stranded costs.

9. We are aware that a number of utilities are at this time seeking out and deploying advanced meters and advanced metering capabilities in New Hampshire and it is essential that those activities are supported through this process. We believe that a closer examination of the Federal Standards by this Commission and the parties to this docket is necessary and we support it.

10. In addition, we believe that a strong advanced metering infrastructure will not only expand the potential for offering of time-differentiated rates to customers, but could also widen availability of a variety of other products and services as well.

11. This Commission has also asked how the Time Based Metering and Communications standards should be implemented. Our answer is that this Commission should use the procedural process, as outlined in its September 14, 2006 Letter to the Parties, to include and undertake "technical sessions" in which to sit down and discuss the details around how the Commission, the utilities and the other parties to this proceeding address the very substantial technical details that revolve around the creation of time-variant pricing options in tariffs as well as a discussion regarding the functionality issues regarding advanced meters and creation of advanced metering infrastructures (AMI) that support and facilitate the time-variant tariff rates.

12. This may not be a quick process, but it is one that will facilitate advantages for utilities and customers alike for a long time, and the technical work will certainly take more than one or

two meetings to complete. We are committed to playing a significant role and providing our expertise in these types of processes to New Hampshire.

13. Regarding the Commission's scoping document on Time Based Metering and Communications, Hunt believes that most of the questions posed on pages 3-4 are just the kind of questions best suited for "technical workshop sessions" as opposed to simply taking responses from parties at this time. Hunt has participated in over 15 state EPACT rulemakings just like this one, and our experience has been that the technical details are so highly important to the successful outcome of this process and investigation that it is necessary to include a series of workshops and discussions in order to move things to the next level. One state, among several who have taken this approach, is Texas. They included a series of working group meetings in order to explore the technical details. We would be happy to provide further information to the Commission on the Texas activities or other state processes as you are interested.

#### **CONCLUSION**

Hunt Technologies looks forward to working with the New Hampshire PUC, the various utilities and other parties to this proceeding in exploring the development of next steps towards creation of an advanced metering infrastructure and the development of even more significant time-variant pricing and tariff offerings that provide benefits to the customer and operational efficiencies to the utilities.
