

**BAYRING'S ESTIMATE OF IMPROPERLY BILLED  
VERIZON NEW HAMPSHIRE ACCESS CHARGES**

NOW COMES Freedom Ring Communications, LLC d/b/a BayRing Communications (“BayRing”) and submits an estimate<sup>1</sup> of the general order of magnitude of the disputed charges billed by Verizon New Hampshire, in accordance with Order No. 24, 705 (November 29, 2006). BayRing’s estimate is based upon bills submitted to it by Verizon New Hampshire. The calculations were primarily made by reviewing each applicable separate exchange within Verizon’s monthly invoices. Minutes of usage were then multiplied by the rate for the particular rate elements that BayRing believes have been incorrectly billed by Verizon. The attached work papers are submitted in support of BayRing’s calculations. Because BayRing considers the information in the attached work papers to be confidential, proprietary and competitively sensitive financial information, this information is being submitted pursuant to RSA 378:43<sup>2</sup> to the Commission only.


