C1: The 'preliminary plan' was filed on 3/31/09. It is not clear to Staff that all of the proposed investment is consistent with the requirements of 2.5.3. Staff will work with FRP to ensure the plan complies with the agreement.

- C3: The proposed billing format was received six weeks late (stamped June 12th 2008) and included many instances of "Verizon" and its trademarks (e.g., " Verizon Freedom" calling bundle) in the example. The OCA and Staff reviewed and recommended changes that did not appear in the final format.
- C4: FRP has filed no commercial agreements with the Commission and reports that it has concluded no such agreements per 9.2.
- C6: The agreement calls for FairPoint to file monthly reports on "progress on Network Improvement Plan" until the NIP is filed. FRP continues to file these, implicitly confirming that no full NIP has been filed.
- C7: FRP's Network Improvement reports are lists of individual work orders. There is no "root cause analysis" at the system level for example, no analysis or even speculation about the quality of the OSP in particular geographic areas. The reports appear to be entirely reactive.
- C8: FRP filed its first inventory and status report on pole removal on 30-Sep-08. This contains the data required in quarterly reports on "inventory and removal of double poles" but does not include a "detailed work plan." For example, a plan would include quarterly targets for pole removal that would reach the target of 500 or less by 31-Jul-10.
- C9: This deliverable refers to part of 12.2.2.1: "an asset-type schedule, the form of which shall be agreed upon in good faith between FairPoint and Staff after the closing date. In the event FairPoint and Staff are unable to agree on the form of the asset-type schedule, the form of the schedule shall be determined by action of the Commission."
