As you know, I represent District One, on the Executive Council. On behalf of my constituents, I am writing in support of FairPoint Communication's efforts to expand broadband to areas of its service territory that are currently without high speed broadband. I support the use of FairPoint's service quality penalties for broadband expansion. I was pleased to see that FairPoint has agreed to contribute an additional \$500,000 to this effort. Over \$3 million dollars will go a long way in bringing broadband service to our citizens in rural areas.

The Public Utilities Commission's order of May 8, 2012 contains a reference to potential additional penalties being imposed upon FairPoint. FairPoint should be commended for its willingness to contribute additional funds of \$500,000 for this project, not penalized. I fear if the Commission imposes additional penalties that the company will elect to just issue a rebate to customers of the SQI penalties and our un-served population will continue to be un-served by broadband.

I urge the Commission to not allow additional penalties to stand in the way of broadband expansion to our state's un-served areas. Thank you for your consideration of this letter.
