Renewal Registration as a Competitive Natural Gas Supplier

Dear Mr. Gusman:

On July 30, 2012, Glacial Natural Gas, Inc. (Glacial) filed with the Commission an updated application for renewal of its registration as a competitive natural gas supplier (CNGS), together with the renewal application fee of \$250.00. Glacial, at Staff's request, filed a series of updates to its application, incorporating additional information and a properly-filed surety bond.

Following its review of the filing, as updated, Commission Staff has determined that the renewal application for registration as a CNGS meets the requirements for registration pursuant to N.H. Code Admin. Rules Puc 3003.02. On November 26, 2012, Staff filed its final recommendation to approve the application.

The Commission will approve the registration with an effective date of September 10, 2012, which coincides with the expiration of the existing registration for Glacial. The renewal registration will expire at the end of business on September 9, 2017. This Commission strongly urges Glacial to keep the Commission informed of the compliance status of Glacial, and its affiliates nationwide, going forward. Additionally, please bear in mind that, pursuant to N.H. Code Admin. Rules Puc 3003.02(a), each CNGS shall reregister with the Commission by filing an application for renewal at least 60 days prior to the expiration of its registration, i.e., in the case of Glacial, on or before July 10, 2017. Please file a timely renewal application. Registration instructions and a checklist of requirements to properly file a renewal registration application are located on the Commission website at http://www.puc.nh.gov/Gas-Steam/CNGS-Aggregator%20registration%20application%20instructions%20and%20checklist.pdf.
